Bursaries are granted by the Bishop for the purposes of the Fund and normally with the intentions of serving the Church in the Diocese of Fredericton mindful of the terms of the various contributing trusts and in accordance with Canon Five s.2(1) and Regulation 5-1.

Divinity students shall apply to the Fund prior to 30 June each year with the expectation that successful applicants will receive one-half of the bursary by 01 September and the remainder by 01 January of the current academic year. Bursaries will not normally be in excess of \$4000 per year.
