- (b) Cause this Notice, together with the attachments, to be read at each worship service in the parish for at least four weeks,
- (c) If your parish publishes a Sunday bulletins, cause this Notice, together with the attachments, to be published in the bulletins for at least four weeks, and
- (d) If possible, post this Notice, together with the attachments, on your parish web site and circulate the notice electronically to voting members in the parish.

Canon SIX, s. 11(3), provides that the Parish Corporation or any ten persons who worship in a church or churches in the parish and who are eligible to vote at meetings of the parish community may, within three months after the date of this Notice, notify the Bishop in writing that they object to the proposal, setting out the grounds of their objection.
