## MINUTES OF THE 132<sup>nd</sup> SESSION OF THE DIOCESAN SYNOD OF FREDERICTON 09 November 2013 The Most Rev'd Claude W. Miller, Chair Saunders Irving Chapel, Kingswood University Sussex, N.B.

The 132<sup>nd</sup> Session of the Diocesan Synod of Fredericton was convened at the Saunders Irving Chapel (Wesley Hall) of Kingswood University in Sussex with registration of delegates beginning at 8:00 a.m.

## CALL TO ORDER

The Most Rev'd Dr. Claude W. Miller, Bishop of Fredericton and Metropolitan of the Province of Canada called the gathering to order at 9:00 a.m. and opened the session with prayers. Greetings were offered to everyone. The Archbishop indicated it is always good to gather as a Synod to discuss important things within the context of the Church.

## **RULES OF ORDER AND DECORUM**

The Chancellor called attention to pages 4-9 of Section A in the Convening Circular. He drew special attention to section 4 of Canon 2 "Order and Decorum" which directs members of Synod on procedure during the session of Synod.

## CLERGY REPORTS

In accordance with Canon Seven, section 6(b), the Archbishop called on clergy to submit their reports in the area provided.

## REGISTRATION

The Archbishop received the report of the Credentials Committee. Ashley Sobey, Chair indicated in the House of Clergy 71 members out of a possible 79 had registered; and that in the House of Laity 206 out of a possible 240 had registered.

Quorum was declared the 132<sup>nd</sup> Session of Synod was convened.

# holding a meeting of Synod to the third year following the last meeting of the Synod.

The Motion was carried in both houses.

## MOTION 02 - Parish Returns

Geoffrey Hall / Clyde Spinney, Q.C. That the Diocesan Constitution be amended by adding the following subsection 4(13) immediately after subsection 4(12) thereof:

> 4(13) Notwithstanding any other provision of the Constitution, lay members of the Synod elected as delegates are entitled to vote at a meeting of the Synod if, since the preceding meeting of the Synod, their parish has completed and filed all Parish Forms (Annual Returns) required by regulation under Canon Five. \*See Resolutions 131-14, Section C, page 19

The mover introduced the motion stating that it emphasizes the need for parish returns in executing the proposed approach to parish support of the shared ministry budget and the information contained will now determine the number of delegates to General Synod. The last Synod requested this issue be considered and action taken by the Diocesan Council.

Two amendments were proposed, a friendly ammendment made, all defeated in the House of the Clergy.

When the question was called, Motion 02 was defeated in the House of Clergy.

## Archbishop's Comments:

Synod Office Staff and Diocesan Council have done everything possible to encourage parishes to submit their Parish Forms at the end of each year. Yet, there are always some parishes who fail to do so. It is difficult to understand why this happens. The Synod Office has offered to help to facilitate the transfer of information, and will always accept paper forms submissions, if necessary. What message is this conveying to the Diocese? As mentioned in the Charge, what we do has an effect beyond ourselves. It this case, it affects the Diocese in its ability to plan an accurate and fair Shared Budget. It now affects our delegation to General Synod. The intent of the motion was not to be punitive, but rather a call to compliance and introduce a consequence – to do what we, as parishes, are already required to do by Canon Law.

Now that the motion has been defeated, it is hoped that all members of this Synod, lay and clergy, will take responsibility to make sure returns are submitted in a timely manner. If we are to be members of the Body, we need to be responsible parts of the Body, more sensitive to one another and be full members.

a) approve, in principle, the approach to parish support of the shared ministry budget as presented to October 2013 meetings of the Archdeaconry Greater Chapters, and;
