#### Membership

The Credentials Committee advises that it is important for those who intend to exercise membership of the Synod confirm that their name appears on either the list of licensed clergy or elected lay delegates and substitutes. **PLEASE REFER TO SECTION B.** Those who feel the lists are in error need to take steps, prior to registration on the day of Synod, to clarify their status. Clergy not listed should contact the Bishop's Secretary prior to registration and lay delegates, or lay substitutes replacing a delegate, not listed should assure the completion of the <u>form of Certification of a Synod Delegate</u> prior to attempting to register.

#### Registration

Registration opens at 8:00 a.m. Please register upon arrival at the synod session on Nov. 2 as a quorum will be required to convene the Session.

#### **Convening Circular**

Please become as familiar as possible with the contents of this circular and bring it to the meeting of Synod. Additional copies will not be available. **If lay delegates are unable to attend the session of synod, this circular must be passed to the substitute from the same parish attending in their place.** Those using a digital version of this circular should download it to a laptop, tablet or mobile device prior to arriving at the venue, if possible. Please note that many of the reports and appendices from the 2018 unused circular are not reprinted here but will be available online as a separate document.

#### **Clergy Reports**

Canon Seven 6(b) requires all clergy having a cure of souls, to "deliver to the Bishop at each regular meeting of the Synod a report of the work done in the parish since the previous regular meeting of the Synod." The Bishop requests that the report be a personal assessment of the ministry implemented and of the plans for the future which are being considered. This means that report should not be in the form of the annual statistical returns or the rector's annual report to the congregation.

# **RESPONSIBILITIES OF A MEMBER OF SYNOD**

Lay Delegates to Diocesan Synod elected by parishes have responsibilities to the Diocese and to the parish until they are replaced at a subsequent annual meeting of parishioners according to the Constitution, s. 4. All Clergy licensed in the Diocese are members of Synod.

- (1) Lay delegates, although elected by the parish, are "members" of Diocesan Synod and responsible to it when in session.
- (2) Synod members, when Synod is in session, act and vote as members according to their conscience and Christian understanding.
- (3) Synod members have the responsibility of reporting and explaining the action of Synod in a positive way at the parish level.
- (4) Synod members need to be familiar with the life of the Church at the parish level to guide their discussion at Synod and on committees at Synod, and be familiar with the structures of the Diocese so as to facilitate understanding at the local level.
- (5) Prior to any meeting of Synod, synod delegates will familiarize themselves with the agenda and any material pertaining to the said Synod.
- (6) Synod members should give leadership and accept election and/or appointment to Diocesan committees.
- (7) Synod members shall attend Archdeaconry Greater Chapter meetings when called by the Archdeacon.
- (8) Synod members are expected to promote the work of the Church at the parish, diocesan, and national level, as well as overseas.
- (9) Synod members ought to promote the actions of Synod, once decided upon, whether or not they voted in favour.

# CANON TWO -- THE BUSINESS OF THE SYNOD

# PART I - RULES OF ORDER AND PROCEDURE

## Definitions

1 In this Canon

"Chair" means the Bishop or other person presiding at a meeting of the Synod; "member" means a member of the Synod.

## The Chair

2(1) The Chair is responsible for preserving order and decorum at meetings of the Synod by

(a) recognizing members who wish to speak and determining the order of speakers,

(b) inviting the mover of a motion to present the opening and closing arguments on the question,

(c) facilitating discussion and enabling the members to hear and listen to each other,

(d) ensuring that all voices are heard and that none dominates,

(e) ruling, when necessary, that speeches be limited to a specified time limit,

(f) ruling whether proposed procedural motions or amendments to motions are in order, and

(g) putting the question to a vote when all views have been sufficiently expressed.

2(2) The Chair may request the advice of the Chancellor on questions of order and shall rule on such questions, stating the applicable rule or practice without argument or debate.

2(3) Any member may appeal the Chair's ruling on a question of order and the Synod shall decide the appeal without debate.

2(4) The resolution referred to in subsection 2(3) is valid without approval of the Bishop or other chair.

## Sessional Committees

3(1) The Chair shall appoint for each regular meeting of the Synod a Credentials Committee, an Agenda Committee, a Nominating Committee, a Resolutions Committee and such other sessional committees as are deemed necessary.

3(2) The Chair shall appoint for any special meeting of the Synod a Credentials Committee and such other sessional committees as are deemed necessary.

3(3) The Chair shall announce the names of the members of sessional committees when the Synod convenes for business.

3(4) The Credentials Committee shall

(a) register the names of the members in attendance at the meeting,

(b) report to the Chair any question about the standing of persons claiming membership, and

(c) report to the Chair as to whether there is a quorum.

3(5) The Agenda Committee shall propose the agenda for each day of the meeting.

3(6) The Nominating Committee shall

(a) receive nominations from members for the election of representatives to the Provincial and General Synods and to any other position to which the Synod is required to elect, and

(b) supervise the election process.

3(7) Subject to the age qualification in section 12 and to any requirement that a position be filled by a member of the Order of Clergy or a member of the Order of Laity, all members of the Synod and all substitute lay members of the Synod, whether they are present at the Synod or not, are eligible to be nominated for election to the Diocesan Council, as representatives to the Provincial and General Synods, and to any other position to which the Synod is required to elect.3(8) When two or more persons receive an equal number of votes on a ballot of the Synod for the election of representatives to the Provincial and General Synods or any other position to which the Synod is required to elect, the Diocesan Council shall resolve the tie or ties by ballot at its first meeting after the meeting of the Synod.

3(9) Neither the Nominating Committee nor the Chair shall accept a nomination unless the nominee has expressly consented to nomination.

3(10) The Resolutions Committee shall receive resolutions from members and prepare them for submission in accordance with guidelines approved by Diocesan Council.

# **Order and Decorum**

4(1) Members are responsible for assisting debate by

- (a) identifying themselves and addressing all remarks to the Chair,
- (b) confining their remarks strictly to the motion being considered,
- (c) stating their positions clearly, succinctly and without repetition, and
- (d) maintaining an impersonal tone and avoiding personal comments.

4(2) A member wishing to speak shall rise and address the Chair.

4(3) When two or more members rise at the same time, the Chair shall determine the order in which they shall speak.

4(4) A member called to order while speaking shall sit down, unless permitted by the Chair to explain.

4(5) A member, if not interrupting a speaker, may at any time request that the motion being debated be read for clarification of the debate.

4(6) Subject to subsections (7) and (8), no member shall speak more than once on the same question.

4(7) A member who makes a motion may speak a second time to close the debate on the motion. 4(8) An address by the Bishop is in order at any time.

# **Courtesies of the Synod**

5 The Chair may invite a person who is not a member of the Synod to sit with the Synod or to address the Synod but that person shall not participate in debate or vote.

# **Reports of Committees**

6 Reports of the Diocesan Council, the Finance Committee, the Constitution and Canons Committee and any other committee required to report to the Synod shall be in writing and signed by the Chair of the Council or Committee.

# **Notices of Motion**

7(1) Members may give notices of motion

(a) during a meeting of the Synod, for consideration at the next regular meeting of the Synod and, in the absence of the member who gave such a notice, the motion may be made by any other member, and

(b) by sending the same to the Secretary of the Synod not less than six weeks before a regular meeting of the Synod.

7(2) The Secretary shall cause notices of motion given pursuant to subsection (1) to be printed in the notice of the meeting in the order in which they were given or received.

7(3) Members may give notices of motion during a meeting of the Synod at times appointed by the Agenda Committee.

7(4) Motions of which notices are given pursuant to subsections (1) and (2) shall be considered in priority to motions of which notices are given pursuant to subsection (3).

# Motions

8(1) No motion or amendment is before the Synod unless it is seconded and in writing.

8(2) No original motion, except a procedural motion, shall be received without notice unless permitted by the Synod.

8(3) No motion that would result in a new expenditure may be considered unless it identifies a proposed source of funding or is qualified as being subject to available funding.

8(4) When a motion has been read by the Chair it cannot be withdrawn without the consent of the Synod.

8(5) When a motion is being considered, no other motion shall be received except

(a) to adjourn,

(b) to lay it on the table,

(c) to consider it clause by clause,

(d) to postpone it until a certain time,

(e) to postpone it indefinitely,

(f) to refer it,

(g) to amend it, or

(h) that the question be put,

and such motions have precedence in the order named, following a motion to put the question. 8(6) No more than one amendment to a proposed amendment of a motion is in order at one time. 8(7) Motions to adjourn, to adjourn the debate, or to lay a motion on the table shall be decided without debate.

8(8) A motion that the question be put shall be decided without debate and, to be carried, requires the affirmative votes of two-thirds of the members present.

8(8.1) The motion referred to in subsection (8) is valid without approval of the Bishop or other Chair.

8(9) Debate on a motion to refer shall be restricted to the questions whether to refer and to whom.

8(10) When amendments to a motion are proposed, the amendments and the original motion shall be put in the reverse order to that in which they were made.

8(11) When the Chair declares that a question is being put, no further debate shall be allowed and no member shall rise.

# Voting

9(1) When the votes of the clergy and of the lay members are required to be taken separately under subsection 8(2) of the Constitution or upon any motion to amend the Constitution or to adopt, amend, suspend or repeal a Canon, the question shall be put first to the order of the mover. 9(2) In voting, those who vote in the affirmative shall so signify first, and then those who vote in the negative.

9(2.1) Notwithstanding subsection (2), at the direction of the Chair or at the request of twenty members, voting on specified business shall be by ballot.

9(3) If there is an equality of votes, either of the Synod voting collectively or in the votes of either the clergy or the lay members taken separately, the Chair shall declare the question to have been decided in the negative.

9(4) A question, once determined, shall not again be drawn into discussion at the same meeting of the Synod without the permission of the Chair.

# Suspension of the Rules of Order

10(1) A motion to suspend a Rule of Order and Procedure shall take precedence over all other motions, shall be decided without debate, and to be carried requires the affirmative votes of two-thirds of the members present.

10(2) The motion referred to in subsection (1) is valid without approval of the Bishop or other Chair.

# **Unprovided Cases**

11 When a question of order is not covered by these Rules, the Chair may refer to Kerr and King's *Procedures for Meetings and Organizations* for guidance.

# In Memoriam

#### **The Reverend James Harris Appleton** 1953 - 2019

Born in Moncton, the Rev. Jim Appleton first trained as a lawyer and worked in several places across Canada. Later in life, he obtained a Master of Arts (Theology) at the Atlantic School of Theology. He was ordained deacon in 2018 and priest later that year. At his passing, he was incumbent in the Parish of Fredericton Junction, a palliative care chaplain and diocesan representative on the AST Board of Governors.

#### The Reverend Martha Jane Arnott

1935 - 2017

The Rev. Jane Arnott was born in Bowmanville, Ontario. She first trained and worked as a nurse. Later in life she completed a Bachelor of Arts followed by a Master of Divinity at Trinity College in Toronto. She was ordained a deacon in 1991 and a priest in 1992. Following some years ministering in Newfoundland, she and husband Murry moved to New Brunswick where she served in the parishes of Madawaska and Grand Falls, and then in Canterbury, Benton and Kirkland.

#### The Reverend Lewis Dick Black

1957 - 2019

Originally from Saint John, the Rev. Dick Black worked for many years in business, at one point completing a Master of Business Administration from the University of New Brunswick. He then completed a Master of Divinity from Wycliffe College and was ordained deacon in 2008 and priest in 2009. Dick served in the Parish of Salisbury and Havelock and the Parish of Bathurst before illness forced an early leave.

#### The Reverend David Cole (later Dr. Gifford-Cole) 1930 - 2018

The Rev. David Cole was born in England and ordained there, deacon in 1956 and priest in 1957. He was received in the Diocese of Fredericton in 1960 and served in the Parish of Simonds for seven years before serving as NB District Secretary of the Canadian Bible Society for another seven years. He then moved to British Columbia.

#### Captain Janet Grace (Claxton) Edwards 1953 - 2018

Janet was born in London and worked as a high school teacher in the UK before immigrating to New Brunswick in 1998. She was commissioned as an evangelist with the Church Army, first working with David to establish Taylor College in Saint John. She then served at the Coverdale Centre and as parish evangelist with the Parish of Lakewood/Fundy and the Lakes.

#### The Reverend Roy Frederic Embley

1916 - 2017

The Rev. Roy Embley was born in Lytham St Annes, Lancashire, England and moved to Canada in 1949. He was ordained deacon in 1959 and priest in 1960. After

moving to New Brunswick, he served in the parishes of Dalhousie, Simonds and Fredericton Junction. He moved to Edmonton in retirement.

#### **The Reverend John Franklin Farmer** 1926 - 2018

The Rev. John Farmer was born in Woodstock in 1926. He attended Mount Alison University, Wycliffe College and King's College. He was ordained deacon in 1954 and priest in 1955 after which he served in the parishes of Fredericton and Stanley. In 1961, John joined the Black Watch Regiment and served as a Chaplain to the Armed Forces until he retired in 1981.

#### **The Reverend Canon David Bryans Jackson** 1931 - 2019

Canon David Jackson was born in Yorkshire, England, and following graduation with an agricultural diploma he started a career in that field. He emigrated to Canada in 1959. In 1961, he began to pursue a Bachelor and then Master of Theology at St. John's College in Winnipeg. Following his ordination as deacon in 1964 and priest in 1965 he served for 8 years in the Diocese of Rupert's Land. He moved to the Diocese of Fredericton in 1973 and served in the parishes of Wicklow, Wilmot and Peel, Westfield and Coldbrook – St. Mary, as well as the Anglican Church's first official full-time hospital chaplain at Saint John Regional Hospital.

# The Reverend Canon Marjorie Elaine Bulmer Lucas

1923 - 2018

Canon Elaine Lucas was born in Sackville. She graduated from Mount Allison University and Wycliffe College. As a lay person she worked for the Woman's Auxiliary of the Anglican Church of Canada in the Dioceses of Caledonia (northern BC) and Toronto. Elaine also had an extensive business career, working in secretarial and managerial positions in Sackville, Quebec City, Toronto and London. Elaine was ordained a deacon and then a priest in 1996. She served at Bishop Cronyn Memorial Church, London, for two years before returning to her home province. In 1999 she was appointed Pastoral Assistant at Christ Church Cathedral, retiring in 2003, and was made an Honorary Canon of the Cathedral the same year.

## The Reverend Canon William (Bill) Roland MacMullin

1945 - 2018

Canon Bill MacMullin was born in Fredericton. He studied at the University of New Brunswick and Wycliffe College, receiving a Master of Divinity. He was ordained deacon in Toronto and then priest in the Diocese of Newfoundland in 1975. Bill began his ministry in Port Saunders in the new diocese of Western Newfoundland. After returning to New Brunswick he served in the parishes of Campbellton, Carleton, and Douglas and Nashwaaksis, where he continued to serve as an honorary assistant. Throughout his life he was also actively involved with many other ministries, most recently the Canadian Bible Society.

#### **The Reverend Theodore Charles Cameron Reinhardt** 1932 – 2018

The Rev. Theodore Reinhardt was born in Montreal. He was ordained deacon in 1965 and priest in 1967 in the Diocese of Saskatchewan. He also served in the Dioceses of Montreal, Quebec, Ottawa and Algoma. He served in this diocese in the Parish of East Saint John in the late 1980s and in the Parish of McAdam in the early 1990s, before transferring to the Diocese of Moosonee. He was a drummer and teacher of drumming with the Black Watch (Royal Highland Regiment) of Canada.

#### The Reverend Ronald John Rippin

1927 - 2018

The Rev. Ronald Rippin was born in Pretoria, Ontario. He began his career with the Royal Canadian Mounted Police in New Brunswick, serving from 1947 to 1968. He then completed a Bachelor of Ministry degree at Huron College and was ordained a deacon in 1970 and a priest in 1972. Ron served in the parishes of Canning and Chipman, Oromocto and at Christ Church Cathedral, and in retirement in the Parish of Johnston.

#### **The Reverend J. Douglas Patstone** 1946 - 2019

The Rev. Doug Patstone was born in Ontario and raised in Westfield. He first served as Church Army Captain, prior to completing a Licentiate in Theology at Wycliffe College followed by ordination as deacon in 1976 and priest in 1977. Douglas served five years in the Parish of Fredericton then in parishes in British Columbia and Ontario before returning to the Parish of Bathurst in 2000, followed by the Parish of Lakewood. After retirement he left the Anglican Church in Canada for the Anglican Network in Canada.

# The Reverend Donald Douglas McLeod Sharp

1930 - 2018

The Rev. Don Sharp was born in Hampton and initially worked as a bookkeeper in the family business. He then studied for the ministry at Medley Hall and was ordained deacon in 1964 and priest in 1965. Don served in the parishes of Hampton, Portland, Upham and Restigouche, before transferring to the Diocese of Nova Scotia and Prince Edward Island

#### Philip Norman Williston

1936 - 2018

Philip Williston was born in Chatham, NB. He attended Bishop's University, receiving a B.A. followed by a Licentiate in Theology. He was ordained deacon in 1963 and priest in 1964. Philip served in the parishes of Addington, Coldbrook - St. Mary, Chatham, Hampton and Grand Manan, and was made a Canon of Christ Church Cathedral in 1983. He retired in 1997 and relinquished his ministry in 2000.

#### **ANNOUNCEMENTS**

The Ven Cathy Laskey noted that housekeeping announcements were contained in the delegate package and only First Aid and Safe Church announcements would be provided from the floor.

The Rev'd Chris Ketch introduced the Synod first aiders and provided basic instructions for first aid emergencies

Ben Bourque talked about safe church, how to find information online, and the response the Diocese has taken from feedback on training. The online training will be updated. He noted the location of building exits, washrooms, fire extinguishers and fire alarms.

#### **REVIEW OF THE RULES OF ORDER AND DECORUM**

The Chancellor reminded Synod of the responsibilities of all members and that Synod gathers to deal with the temporal matters of the Diocese of Fredericton. He noted that the Rules of Order and Procedure could be found on pages 4 to 8 of Section A of the Convening Circular and that anyone wishing to place a motion before Synod needs to provide a written draft of his or her resolution to the Resolutions Committee before 10:10 am. The resolutions committee will make sure everything is in order and that the motion states what the mover and seconder want it to say.

Motion 135-05 – Nancy Wiggins / Neville Sloane That the report on the Status of Resolutions of the 134<sup>th</sup> Session of the Diocesan of Fredericton (Section C, pages 15-16) be approved as circulated.

Motion carried.

#### CORRESPONDENCE

The Ven Cathy Laskey read correspondence sent to the Synod from the Office of the Prime Minister and the Requests Officer to the Archbishop of Canterbury.

#### **MORNING PRAYER**

The Very Rev'd Geoffrey Hall led the Synod at Morning Prayer. The offering of \$1786.80 was directed to the construction of the Anglican Seminary Library at Bishop McAllister College.

#### **BISHOP'S CHARGE**

The Bishop based his charge to those gathered for the 136<sup>th</sup> Session of Synod on Matthew 22:35-40. In his charge the Bishop reminded delegates that love is absolutely everything and called synod delegates to consider our purpose as the Church and how we can reach out to the world that God loves. Copies of the charge will be made available on the Diocesan website after Synod.

#### **BREAK**

The Bishop called for a break and asked members to return within in 15 minutes. Synod was called back to order at 10:40 am.

#### **PROGRAM**

The Bishop introduced the program portion of synod with a video that envisages the Church as a Missional community. He then spoke about the book *Surprise the World: the 5 Habits of Highly Missional People* and the BELLS model for mission proposed by the books author Michael Frost. The author uses the acronym BELLS to remind readers of the five habits: Bless, Eat, Listen, Learn, Sent.

Threshold Ministries' national director Shawn Branch facilitated the program session, introducing videos for each habit, interviewing a member of the Diocese who illustrates the habit, and praying for their ministry after their interview.

#### **B** is for Bless

Frost explained the value of supporting and affirming and suggested blessing three people each week. Dawn Mary Baker, a member of the Parish of Madawaska, discussed her mission, which illustrates blessing. A retired nurse, she shares her experience, skills and compassion with the women of the Edmundston region, a city with its share of drug abuse, alcoholism and family violence.

#### <u>E is for Eat</u>

Frost suggested eating with one member of the church, one non-Christian and one more person each week. Shawn interviewed Rob Pitman, Threshold Ministries' parish evangelist and the outreach pastor at St. Luke's in the Parish of Portland. Rob runs a food ministry serving more than 5,000 meals a year. Rob explained how volunteers used to stay in the kitchen, but now they know that the real mission is with the diners.

#### L is for Listen

Frost explained the importance of creating space to listen for the prompting of the Holy Spirit. Missional people must be in tune with the outside world, yet remain different from the world. Anna Caines explained how listening to the Holy Spirit changed her life and she described to Synod how she regularly sits in quiet meditation in God's love.

#### **MID-DAY PRAYER**

The Rev'd Paul Ranson led the Synod at mid-day prayer.

#### **LUNCH**

The Rev'd Paul Ranson offered a prayer of thanksgiving for lunch and the Synod recessed at 11:50 am.

#### **PROGRAM**

Synod reconvened at 12:50 pm to continue with the program.

#### L is for Learn Christ

Frost made an important distinction between knowing about Jesus and really knowing Jesus. Learning Christ means being continually shaped by Jesus by finding at least one time a week solely for immersing yourself in the example of Jesus — reading aloud, using study materials and entering into the story. Erik Sample was the next guest. He and his wife, Nicole, are house parents at the Bishop's Court community. They oversee and mentor several young people. He explained how Bishop's Court provides an opportunity to be immersed in a community of people who want to know Jesus, who read the bible together, and eat together. Erik said that immersing himself in the gospels changed his life and motivates him to live life differently.

#### S is for Sent

Frost noted that the word mission means to be sent and that many mistakenly believe that only those ordained are sent. Klaudia Ross explained how the Holy Spirit called her over time, and rather persistently, to leave her career as a cancer researcher. She is now the Parish Outreach Coordinator at St. George's in Moncton.

Shawn Branch wrapped up the BELLS portion of the program by summarizing key points and leading the Synod in prayer.

#### **Hockey Ministries International**

Bishop David introduced Bruce Smith of Hockey Ministries International. Bruce works extensively with hockey leagues in the Maritimes, offering chapel services in arenas. Bruce noted the continual conflict between church and hockey on Sunday mornings. His call has been to stop waiting for people to choose church, and instead, take God to where they are. He recalled the QMJHL president being shocked when Bruce told him that 56 of his players had requested a bible. Bruce noted that this ministry is a work of God and that he has discovered lots of people out there need a shepherd. Bruce advised Synod delegates to take a risk and extend an invitation. At the end of Bruce Smith's presentation, the Bishop thanked him and prayed for his hockey ministry.

#### Motion 136-06 – Rev David Peer / Coralie Losier

- a) That the Diocesan Synod recommend to the Greater Chapters that their January/February meeting agenda include the video series based on the book Surprise The World: The Five Habits of Highly Missional People by Michael Frost;
- b) That the Archdeacon, Lay and Cleric members of Diocesan Council from each Greater Chapter work together to provided leadership for this meeting and encourage and support the clergy, parish lay and substitute synod members and wardens to enable parishes or groups of parishes to engage with the book during Easter;

#### OMNIBUS CONSTITUTIONAL AND CANONICAL AMENDMENTS

**Motion 136-10** - Sandra Craft / The Very Rev'd Geoffrey Hall **That the constitution of the Diocesan Synod of Fredericton and Canons One, Five, Six, and Seven be amended as follows, such amendments to become effective on 15 November 2017 (Section D, pages 3-12).** 

Comments:

The Chancellor noted that the 135<sup>th</sup> Synod had requested the NB Legislature to make a detailed schedule of changes to the Anglican Church Act. The Legislature amended the Act and it received Royal assent on 5 May 2017. It will be proclaimed in force on November 15<sup>th</sup>, 2017. The proposed changes in this motion would bring the Canons into line with the amended Anglican Church Act.

Motion carried by voice unanimously in the houses of Laity and Clergy.

#### <u>CANON THREE AMENDMENTS – IMPLEMENTING THE RECOMMENDATIONS OF</u> <u>THE EPISCOPAL ELECTIONS TASKFORCE</u>

Motion 136-11 - Sandra Craft / The Very Rev'd Geoffrey Hall That Canon Three be amended as printed (Section D, pages 13-14).

Comments:

The Chancellor noted that at the 135<sup>th</sup> Synod some members expressed the view that the electoral synod members should have greater opportunity to learn about the nominees for episcopal election. Synod referred the matter to the Diocesan Council, which appointed a taskforce to consider the situation and make recommendations. This motion implements taskforce recommendations that require changes to Canon Three. In addition this motion will make the Diocesan Council the body that calls an electoral synod, a change proposed by the Diocesan Council itself, not the taskforce

Motion carried by voice unanimously in the house of Clergy. Motion carried by voice in the house of Laity with one vote against.

#### <u>CANON TWO AMENDMENTS – ON THE TIMING OF ELECTION OF DELEGATES TO</u> <u>THE PROVINCIAL AND GENERAL SYNODS</u>

Motion 136-12 - Sandra Craft / The Very Rev'd Geoffrey Hall That S.12 of Canon Two be amended as printed (Section D, pages 14-15).

Comments:

The Chancellor explained that the 135<sup>th</sup> Synod asked Diocesan Council to see if there was a way to change Canon Two to bring the election of delegates closer in time to the meetings of Provincial and General Synod, so that the Diocese might not

run short of delegates or substitutes who were both qualified and able to attend. The Chancellor noted there is no wholly satisfactory solution or easy way to do this. The effect of the canonical change in this motion empowers the Diocesan Council to appoint additional substitute delegates should the need arise. The Diocesan Council already has this power in relation to the youth delegate.

Motion carried by voice in the house of Clergy, with two votes opposed. Motion carried by voice in the house of Laity, with three votes opposed.

#### YOUTH DELEGATE/SUBSTITUTE AGE THRESHOLD

Notice of Motion 136-13 – The Rev'd Daniel McMullen / The Rev'd Christian Persaud

Synod was given notice that at the next regular session of the Diocesan Synod, a motion will be presented to lower the age ceiling for youth delegates from 35 to 25.

Comment:

The Rev'd Daniel McMullin explained to Synod that the intent of his motion was for Synod to be intentional about hearing the voice of youth.

#### MEDIATION SUPPORT IN NEW BRUNSWICK FAMILY COURTS

Motion 136-14 - The Rev'd Thomas Nisbett / Ms Kathy Page

That Diocesan Synod urge the Government of New Brunswick to:

a) introduce a system of Mediation Support for all cases proceeding through the New Brunswick Court of Queen's Bench - Family Division that cannot be resolved with a single hearing;

b) give judges in the Court of Queen's Bench - Family Division the option, through legislation, of requiring parties to participate in a Mediation Program prior to any Court hearing; and,

c) establish a cadre of trained, volunteer professionals to provide Mediation Services to parties journeying through the Family Court system.

Comments:

The Rev'd Thomas Nisbett pointed out, while the Church does not advocate divorce over marriage, divorce and its consequences are a reality that requires a pastoral response. He noted the difficulty families are experiencing in the Family Court system and how the lack of mediation services in New Brunswick exacerbates the difficulty when families break up. Delegates rose to speak for and against the motion.

Motion carried.

#### PROTECTION OF RELIGIOUS FREEDOM

Motion 136-15 - The Rev'd Shirley Noseworthy / The Rev. Robert LeBlanc That the Diocesan Synod write the federal Minister of Justice, the Chair of the Standing Committee on Justice and Human Rights, and the Chair of the Standing Senate Committee on Legal & Constitutional Affairs to express the Synod's opposition to the proposed repeal of section 176 of the Criminal Code, which specially protects faith leaders and faith communities from violence and disturbance in worship.

#### Comments:

The mover and seconder adopted a friendly amendment to their motion to Direct Diocesan Synod to include the Chair of the Standing Committee on Justice and Human Rights and the Chair of the Standing Senate Committee on Legal & Constitutional Affairs to the Diocesan Synod correspondence expressing the Synod's opposition to the repeal of section 176 of the Criminal Code. All delegates that spoke were in favour.

Motion carried

#### **REPORT OF CREDENTIALS COMMITTEE**

The Credentials Committee reported that as of 3:00pm the number of delegates registered was as follows:

Clergy: 75 registered out of a possible 76 (98%)

Lay: 149 registered out of a possible 171 (87%)

#### **REMARKS FROM GUESTS**

The Rev'd Richard Bowley spoke for the ecumenical guests. He called the Synod a powerful experience that started with the Bishop's charge. The Rev'd Bowley felt Christ's presence, as he moved around the Synod. He reminded Synod that faith is about taking risks, recalling the story from Scripture when Peter walked on water. It was only when Peter lost his focus that he started to sink. He thanked the Synod for the invitation to attend and for the program presented. He particularly thanked the interviewees for boldly speaking about their love for Christ. He concluded with a prayer for our Diocese.

#### **RESPONSE TO THE BISHOP'S CHARGE**

Mr Lionel Hayter from the parish of St Andrews responded to the Bishop's Charge and noted how well the missional call in the Charge and the Synod Program fit together. He called delegates to focus on love and let it be the guide throughout our missional work. Lionel prayed for action and encouragement as we reach out to the wider community in the days to come.

# **Getting a Motion Before Synod**

**Synod Jurisdiction:** The jurisdiction of the Diocesan Synod is the "government and administration of the temporal affairs of the Church in the Diocese" (*Anglican Church Act*, s.4(1)). In contrast to the Diocese's "temporal affairs", the spiritual affairs of the diocese are the jurisdiction of its bishop, and matters of "the doctrines of the Church" are the jurisdiction of the General Synod (*Declaration of Principles*, s.6).

**Order of Consideration**: [Canon Two, sections 7(4) and 8(2)] Motions will be considered at Synod in the following order:

- 1) Notices given at a preceding Synod for consideration at the current Synod (to be printed in the order given);
- 2) Notices given six weeks before Synod (to be printed in the order received); and
- 3) Notices given at Synod before the deadline set by the Agenda Committee.

Motions of which notices are given under 1) and 2) above shall be considered prior to notices given at Synod under 3).

**Making a Motion:** All substantive motions are initiated by giving a Notice of Motion by way of the required form. Notices of Motion can be given either before or for a brief time during a Synod.

#### Before Synod: [Canon Two, sections 7(1)(b) and 7(2)]

Notices of Motion for regular meetings of Synod can be sent to the Resolutions Committee (<u>resolutions@anglican.nb.ca</u>) not less than six weeks before Synod and when appropriate will be printed in the Synod Journal and in the order received.

#### At Synod: [Canon Two, sections 3(10), 7(1)(a) and 7(3)]

Notices of Motion can be given at a meeting of Synod by delivering the same to the Resolutions Committee before the deadline set by the Agenda Committee. A Notice of Motion can be given for consideration either at the current meeting of Synod or at the next regular meeting of Synod. However, it is preferable to submit motions to the Resolutions in advance and not wait until the day of the Synod.

#### **Procedural Motions:** [Canon Two, section 8(5)]

Procedural motions (such as a motion to table, refer or adjourn) may be made without notice and must be disposed of before consideration of the substantive motion before Synod.

Committee Mandate]

The Resolutions Committee does not have authority to veto or refuse a motion, but will seek to ensure that the language reflects the mover's intent and is in clear and coherent language, and the Committee may recommend clarifications and point out potential concerns. It may also suggest consolidation of a proposed motion with other motions received on the same subject.

#### New Expenditures: [Canon Two, section 8(3)]

Motions proposing new expenditures must either identify a proposed source of funding or be qualified as being made "subject to available funding."

# **Notices of Motion**

# Motion 2019 – 01 – Synod Constitutional Amendment (lowering age ceiling for youth delegates to Synod to 25)

Daniel McMullen/Rob Montgomery

#### MOVED THAT

the Constitution of the Diocesan Synod be amended as follows:

Lay Members of the Synod

4(1) Lay delegates to the Synod and their substitutes, if any, shall be voting members of the parish for which they are chosen.

[etc]

4(2) The voting members of each parish in the Diocese may elect up to two lay delegates to the Synod but, where at least one of the persons elected is between the ages of sixteen and <u>twenty</u>thirty-five years at the time of election, they may elect up to three lay delegates.

4(3) The voting members of each parish in the Diocese may elect up to three substitute lay delegates to the Synod.

4(4) The voting members of the Cathedral of Christ Church in the City of Fredericton may elect up to two lay delegates to the Synod but, where at least one of the persons elected is between the ages of sixteen and **twenty** thirty-five years at the time of election, they may elect up to three lay delegates, and up to three substitutes in accordance with this section.

4(5) Lay delegates to the Synod and their substitutes, if any, shall be elected at an annual meeting of voting members of a parish and, provided they continue to hold the qualifications for election, shall continue in office until others are elected in their place.

4(6) If a vacancy occurs among the lay delegates to the Synod or their substitutes, if any, by death, resignation, refusal to act or otherwise, the parish corporation of the parish in which the election took place may fill the vacancy.

4(7) The chair of a meeting at which lay delegates to the Synod and their substitutes, if any, are elected shall promptly forward to the Secretary of the Synod a certificate of election in such form as the Diocesan Council prescribes, indicating which, if any, delegates and substitutes were, at the time of election, between the ages of sixteen and <u>twenty</u>thirty-five years.

4(7.1) When a worship community is unrepresented in the Synod, the Diocesan Council may invite it to choose up to three lay delegates and substitute delegates to the Synod, subject to age and length of term considerations similar to those for parishes.

4(8) When a lay delegate to the Synod is not present at a meeting of the Synod, that delegate's place may be taken by a substitute lay delegate from the same parish, worship community or the Cathedral of Christ Church, as the case may be.

4(8.1) Notwithstanding any other provision in this section, the number of delegates from a parish, worship community or the Cathedral of Christ Church chosen by virtue of this section who attend the Synod as lay members or substitute lay members is limited to two unless one of the persons so attending was, at the time of election, between the ages of sixteen and <u>twenty</u>thirty-five years. [etc] *Explanation:* At our 135<sup>th</sup> synod, Motion 135-03 was passed which stated that "the age of a youth delegate as referred to in the Constitution be changed from sixteen to twenty-five years to sixteen to thirty-five years."

Some of the reasoning behind this change, as stated in the minutes, had to do with a feeling that the original motion [changing the number of delegates from 3 to 2, but adding a 'youth delegate'] "penalizes rural or out of the way parishes because their youth members have left the area for larger centres."

One of our youth who was present, Mr Colton Scott, spoke against this change at the synod itself. From my conversations with him and many others (both youth and adults) in our diocese, this amendment felt like an avoidance of a problem. 'Our churches do not have many youth, so let us change the definition of what a youth is.'

After a conversation in the fall of 2017, I realized that I, as a priest in the diocese, had the ability to give these concerned youth and adults a small voice by making a synod motion. We were just late for submitting this motion on time for 2017 but were pleased to be able to make a "pre-motion" at last year's synod.

The real concern of myself and others here has little to do with technicalities around synod delegate ages and more to do with being intentional about hearing the voices of youth.

I am aware that this motion would indeed "penalize" some of our parishes, including the ones I work with. Perhaps, though, especially at this time in our diocese with its focus on mission, we should be less concerned with pleasing our own, and more concerned with how to move forward as a people created for and called to love God and neighbour.

We believe a good place to start might be to listen to those groups of people like youth who, though it often feels as though they are done with our churches, are from my experience nowhere close to being done with the King and His Kingdom.

# Motion 2019 – 02 – Synod Constitutional Amendment (tenure of elected lay members of Diocesan Council)

Sandra Craft/Geoffrey Hall

MOVED THAT the Constitution of the Diocesan Synod be amended as follows:

11(4) If a person elected pursuant to the provisions of paragraphs (g) or (h) of subsection (1) fails to complete the term for which elected, the Diocesan Council shall 2 appoint a replacement for the remainder of that term from the appropriate order and from the Archdeaconry in which the person was elected.

11(4.1) A member of the clergy elected pursuant to paragraph (g) of subsection (1) who, following election, is licensed to a new ministry within the same archdeaconry, continues to be a member of the Diocesan Council.

11(4.2) A lay person elected pursuant to paragraph (h) of subsection (1) <del>who,</del> following election, becomes a voting member of another parish within the same archdeaconry, continues to be a member of the Diocesan Council <u>continues to be a</u> <u>member of the Diocesan Council for the duration of its term notwithstanding</u>

# that s/he ceases to be a lay delegate or substitute lay delegate to the Synod from a parish or mission, provided that s/he remains a voting member of a parish or mission.

11(5) If a person appointed by the Diocesan Council pursuant to the provisions of paragraphs (i) or (j) of subsection (1) fails to complete the term for which appointed, the Diocesan Council shall appoint a replacement for the remainder of that term in accordance with the terms of paragraphs (i) or (j) of subsection (1).

Explanation: Each of our seven Greater Chapters elects one lay member of the Diocesan Council. The question has arisen repeatedly whether these seven elected lay representatives of their Greater Chapter vacate their position on Diocesan Council if they cease to be a member of their Greater Chapter. The reason they might cease belong to their Greater Chapter would be that they ceased to be a parish delegate or substitute delegate to Synod because they had moved parish or became term limited. (Term limits will become operative for the first time at the 2019 parish election of synod delegates/substitutes.) The sort of elected lay person who ends up on Diocesan Council is the very sort of person who has likely been a regular synod delegate and hence might become term limited, thereby ceasing to belong to their Greater Chapter. This amendment would allow any such lay member elected from a Greater Chapter to complete his/her term on Diocesan Council even if s/he has ceased to be a member of that Greater Chapter. The rationale is that stability of membership on the Diocesan Council during its (usually two-year) term is important.

# Motion 2019 – 03 –Amendment of Canon Three (post-election procedure for becoming bishop)

Sandra Craft/Geoffrey Hall

MOVED THAT

Canon Three – Election and Appointment of Bishops be amended as follows:

6(1) The person who is chosen by the votes, taken by ballot, of two-thirds of the clergy present and voting, and two-thirds of the lay members present and voting at any such meeting or adjournment thereof, shall be declared elected to the office of Bishop-elect, Coadjutor Bishop-elect, or Suffragan Bishop-elect, as the case may be.

6(1.1) The Bishop-elect takes office on having satisfied the canonical requirements of the Ecclesiastical Province of Canada, consecration and seating in the Cathedral.

6(1.2) A Coadjutor Bishop-elect or Suffragan Bishop-elect takes office on having satisfied the canonical requirements of the Ecclesiastical Province of Canada and on consecration.

Explanation: This amendment would cure misleading language in subsection 6 (1) of our canon on episcopal elections. The current wording implies that a nominee receiving a certain configuration of votes at an episcopal election thereby becomes bishop of Fredericton. This is not so. To become bishop of Fredericton the elected nominee requires confirmation of election by the bishops of the ecclesiastical province of Canada, in most cases consecration, and arguably enthronement in the Cathedral.

The proposed amendment makes no change to current practice. It alters language to make things clearer. The term "bishop-elect" is borrowed from the Diocese of Nova Scotia & PEI.

# Motion 2019 – 04 – Amendment of Canon Four (role of diocesan bishop in managing temporal matters)

Sandra Craft/Geoffrey Hall

MOVED THAT

Canon Four – Diocesan Governance be amended as follows:

1(1) The Bishop of the Diocese shall be elected or appointed as provided in Canon Three.

1(2) The Bishop of the Diocese has the powers, jurisdiction and authority that are inherent in the office of a bishop of the Church or that are conferred by the Act, the Constitution or by any Canon of the Synod, the Provincial Synod or the General Synod.

1(3) The Bishop is the Chair of the Synod and the Diocesan Council and, when present, may preside at a meeting of any Diocesan committee or other Diocesan body.

<u>1(3.1) Subject to the direction of the Synod or Diocesan Council, the Bishop</u> has responsibility for the temporal affairs of the Diocese and has the powers and duties incidental thereto.

1(4) When the office of Bishop is vacant or during the incapacity of the Bishop, the powers of the Bishop in respect of the temporal affairs of the Diocese or of any parish or of any church in the Diocese shall be exercised by the Coadjutor Bishop, the Suffragan Bishop, the Diocesan Administrator or the Bishop's Commissary, in that order.

[etc]

Explanation: Except as regards the role of the Finance Committee in property matters (which is provided for in Canon Five – Diocesan Business), our legislation is largely silent on the location of authority to supervise and otherwise deal with the status of lay employees and to make the other day-to-day contractual commitments and managerial decisions that go with running an organization with a \$2million+ annual budget. By default, those decisions are made by the diocesan bishop or under his/her administration. The proposed amendment acknowledges this temporal role.

# Motion 2019 – 05 – Amendment of Canon Four (role of diocesan bishop in requiring police records checks)

Sandra Craft/Geoffrey Hall

MOVED THAT

Canon Four – Diocesan Governance be amended to add as follows:

1(7) In furtherance of the Safe Church regime, the Bishop shall require persons holding the Bishop's licence for ministry to obtain and file with the Bishop and with any relevant parish corporation, mission or the Cathedral of

#### Christ Church a police records check satisfactory to the Bishop that is directed at work with children, youth or vulnerable adults and to renew it at least every third year, and the Bishop may suspend or revoke the licence in the event of non-compliance.

# **1(8)** Anyone holding the Bishop's licence for ministry who is charged with an offence under the Criminal Code of Canada shall notify the Bishop immediately.

Explanation: Our current Safe Church policy obliges Parish Corporations to require clerics and others to obtain a police records check but many Corporations have not passed such a motion. Even if they do so, they lack a mechanism to enforce it. Recognizing that police record checks are a matter of importance, the proposed amendment would obligate and empower the bishop to require vulnerable sector checks for all ministerial licence-holders. It would also require licence-holders to report criminal charges.

### Motion 2019 – 06 – Amendment of Canons Four and Six (role of archdeacons)

Sandra Craft/Geoffrey Hall

MOVED THAT

Canon Four – Diocesan Governance and Canon Six – Parish Governance be amended as follows:

#### **Canon Four-Diocesan Governance**

6(1) The Bishop shall appoint Archdeacons to **assist the Bishop's ministry of <u>episcopal oversight by</u>** exercis**ing**e territorial or Diocesan supervisory functions.

#### **Canon Six – Parish Governance**

4.1(1) Notwithstanding any other provision in this Canon, when an incumbency is open or an Incumbent is on leave, the territorial archdeacon may call and chair meetings of the Parish Corporation, its committees and annual or other meetings of voting members and may inspect any Parish Corporation record.

4.1(2) An archdeacon acting under subsection (1) does not thereby become a member of the Parish Corporation.

*Explanation:* Parish vacancies can be lengthy. This amendment would authorize an archdeacon to become involved in parish governance where desirable but without becoming a member of the Parish Corporation.

# Motion 2019 – 07 – Amendment of Canon Five (authority of assistant secretary of synod and assistant treasurer)

Sandra Craft/Geoffrey Hall

MOVED THAT Canon Five – Diocesan Business be amended as follows: 3(1) The Bishop and the Secretary of the Synod shall sign all documents that are required to be executed under the seal of the Diocesan Synod <del>or which may subject the Diocese or the Synod to financial or other liability</del> but at the Bishop's direction the Bishop's Commissary may sign in his/her place of the Bishop and the Assistant Secretary of the Synod may sign in place of the Secretary.

3(2) Cheques and other money instruments issued by the Diocese or the Synod shall be signed by any two of the Bishop, the Treasurer of the Synod, the Assistant Treasurer of the Synod, the Secretary of the Synod, the Assistant Secretary of the Synod, the Bishop's Commissary and a diocesan officer or member of the Synod Diocesan staff designated by the Diocesan Council.

*Explanation:* Canon Four allows the Diocesan Council to appoint an Assistant Secretary of the Synod. Appointment of an Assistant Secretary would be useful where business needed doing but the Secretary were on leave (vacation, medical, etc). However, such an Assistant, though appointed under Canon Four, could not perform some of the Secretary's most important duties without the change proposed here to subsection 3(1) of Canon Five.

The deleted words in subsection 3(1) require a double written assent to so many routine transactions as no longer to be realistic.

*Canon Four also allows the Diocesan Council to appoint an Assistant Treasurer. Council has done so on at least one occasion. However, without the amendment proposed here to Canon Five an Assistant Treasurer could not sign cheques.* 

# Motion 2019 – 08 – Amendment of Canon Six (non-Incumbents presiding at parish annual meeting)

Sandra Craft/Geoffrey Hall

MOVED THAT Canon Six – Parish Governance be amended as follows:

Composition of the Parish Corporation

1(1) As provided in the *Anglican Church Act, 2003*, a Parish Corporation comprises the Incumbent together with two Church Wardens and members of the Vestry chosen as provided in section 2.

1(2) The Incumbent is the person appointed to that position or shared position in a parish or mission and includes a member of the clergy appointed as Rector.
1(3) A person appointed to have charge of a parish but who is not an Incumbent is not a member of the Parish Corporation but is entitled to attend <u>the annual</u> meeting of parishioners and meetings of the Parish Corporation with voice but no vote and, if the meeting so decides, may preside <del>at its meetings</del>.

*Explanation:* Our current legislation makes a distinction between the role of a non-Incumbent in presiding at meetings of the parish corporation (which is possible) and in presiding at the parish annual meeting (which is not possible). The suggested amendment would remove this pointless distinction.

# Motion 2019 – 09 – Amendment of Canon Seven (membership of Parish Advisory Committee)

Sandra Craft/Geoffrey Hall

MOVED THAT Canon Seven – The Clergy be amended as follows:

> 2(3) There shall be in each parish a Parish Advisory Committee comprising (a) the two Church Wardens, <del>and</del>

(b) one three-members of the Vestry appointed annually by the Parish Corporation, and
 (c) two voting members appointed annually by the Parish Corporation, at least one of whom shall, if practicable, be between the ages of 16 and 35.

*Explanation:* At present, all members of Parish Advisory Committees are chosen from the membership of the Parish Corporation. The proposed change would widen the pool of possible appointees.

# Motion 2019 – 10 – Amendment of Canon Six (preservation of liability insurance policies; annual disclosure of special trusts)

Sandra Craft/Geoffrey Hall

#### MOVED THAT

Canon Six – Parish Governance be amended as follows:

#### The Parish Corporation

4(1) Subject to the authority of the Bishop and the Synod, a Parish Corporation shall (a) organize and manage activities and programs in furtherance of Christian life in the parish,

(b) manage the investment of endowment and other funds of the parish and, in so doing, may engage professional assistance and pay reasonable fees therefor,(c) dispose of real property only with the approval of the Bishop and the Finance Committee of the Diocesan Council,

(d) manage the properties, revenues and expenditures of the parish, utilizing appropriate financial controls and procedures,

(e) employ the lay employees of the parish,

(f) initiate recommendations for the appointment of assistant clergy of the parish, (g) maintain a book of minutes of its proceedings,

(g.1) preserve all policies and certificates of liability insurance for not less than sixty years,

(h) appoint a Vestry Clerk and a Parish Treasurer, which offices may be held by one person,

(i) appoint annually, in accordance with Canon Seven, a Parish Advisory Committee, to assist the Bishop in the appointment of an Incumbent,

(j) approve or reject a decision by the Parish Advisory Committee to vest the appointment of an Incumbent solely in the Bishop,

(k) prepare and submit to the annual meeting of voting members in the parish an annual report <u>that includes a listing of all special trusts (monies and other</u> property received with conditions) of which the Parish Corporation is <u>trustee and states the terms of those trusts</u>,

#### (k.1) prepare and submit to the annual meeting of voting members in the

**parish** and a full and detailed statement and account of the receipts and expenditures for the past financial year, duly **reviewed** audited by a professional accountant or by two competent persons, and

(I) prepare and submit for approval at the annual meeting of voting members in the parish a proposed detailed budget for the current year.

Explanation: This proposed canonical amendment (a) changes the terminology of annual "audit" to the more realistic "review"; (b) recognizes that changes in limitation of actions legislation make it particularly important that liability insurances policies be retained; and (c) highlights for parish annual meetings and parish corporations the terms of the various special trusts of which the corporation is trustee.

**Motion 2019 – 11 – Amendment of Canon Six (Parish financial signing authorities)** Addie Marshall/Sandra Hamilton

MOVED THAT

Canon Six -- Parish Governance be amended as follows:

10(2) Cheques and other money instruments issued by the Parish Corporation shall be signed by any two of the Parish Treasurer, the Incumbent and a Church Warden. Where this requirement is impractical, such instruments may be signed by any two of four voting members of the Parish chosen for that purpose at the Annual Meeting.

**10(3)** The Parish Treasurer, with the approval of the Parish Corporation, may establish electronic banking protocols with the Parish's banking institution to facilitate the automated payment of recurring bills.

Explanation: Currently, Canon Six provides for parish financial signing authority as follows: 10(1) The Incumbent and the Vestry Clerk, or, if the office of Incumbent is vacant or the Incumbent is on leave, the Church Wardens and the Vestry Clerk, shall sign all documents that are required to be executed under the seal of the Parish Corporation.

10(2) Cheques and other money instruments issued by the Parish Corporation shall be signed by any two of the Parish Treasurer, the Incumbent and a Church Warden.

With respect to the subsection 10(2) restriction on signing officers, all parishes are required to have their annual financial statements audited or reviewed and to report annually to their Annual General Meeting, the Synod and the Canada Revenue Agency. In addition, the Synod tracks stipend and related payments as well as Shared Ministry payments. Parish corporations (Section 4), and specifically the Wardens (Section 6), have a fiduciary duty to oversee and put procedures in place to ensure that money instruments are managed properly regardless of who the signing officers may be.

*This proposed amendment does not prevent any parish from electing one or more of their Incumbent, Warden(s) or Treasurer as signing officers.* 

With respect to the addition of sub-section 10(3), the Synod office prefers that automated payments be made for stipend, shared ministry and related charges. Through pre-

authorized debits, parishes can facilitate the payment of utility and other similar bills such that they are paid in a timely manner, without the parish incurring late fees or other charges, and also reduce the work of the Parish Treasurer.

Current banking practices of various available financial institutions differ from those in place when the subsection 10(2) stipulation for cheque signing authority was adopted, and automated bill payment seems not to have been considered. Parishes, especially rural parishes, need the flexibility to work with their banking institutions in a manner that works best for both parties, and within the rules and regulations governing those financial institutions and a parish. This sub-section 10(2) amendment would permit Parish Corporations to appoint signing authorities, which could still include any of the Incumbent, the Treasurer or a Warden(s), in accordance with the requirements of their banking institution and the logistics of their geographic location. It is also noted that this would reduce the load on the Wardens, especially in situations where/when there is no Incumbent, the Incumbent is on leave, when the Incumbent does not live in the Parish, or when the Incumbent is serving more than one parish.

Banking practices also vary from institution to institution, with some requiring that all signing officers attend the institution together should even one signing officer be changed. While there are some institutions that will vary this stipulation, it is not universal.

#### Motion 2019 – 12 – Cemeteries in Dissolved Parishes

MOVED THAT

Diocesan Council develop a policy and procedures for the perpetual care of cemeteries located within dissolved parishes.

*Explanation:* Resources for the required maintenance might come from interest on investment accounts transferred to the Synod from the affected parishes, which may have bequests designated for this purpose.

#### Motion 2019 – 13 – Intentional Discipleship

Shawn Branch/Christopher Hayes

#### MOVED THAT

members of this Synod encourage parishes to continue the momentum begun through **Surprise the World**'s challenge to lead "questionable" lives by urging fellow Anglicans to accept the Anglican Communion's invitation to enter a season of intentional discipleship, until 2025, to strengthen our identity in and mission to New Brunswick communities.

*Explanation:* The Church is most fully alive when her members recognize their vocation as disciples of Christ, whether lay or ordained, to serve Him in their families and communities. Through the Synod motion **2017-09 – A Missional People** the Synod urged every congregation to do a Lenten study of Michael Frost's **Surprise the World: The Five Habits of Highly Missional People** and its call to lead "questionable" lives. This year, as parish development officer, I am urging the Synod, and through it the diocese, to build on this

*initiative by accepting the Anglican Communion's challenge to the worldwide church to enter a season of intentional discipleship to lead a Jesus-shaped life:* 

<u>http://www.anglicancommunion.org/mission/anglican-witness.aspx</u> It is hoped that this initiative would be led by the ministry-focused Diocesan Council teams.

#### Motion 2019 – 14 – Mission Action Planning

this Synod request each parish to discern and develop a Mission Action Plan during 2020 that outlines its mission, discipleship and ministry focus for the next 5-years.

*Explanation: Templates and personnel resources will be available to assist parishes in the discernment and implementation of the plans.* 

#### Motion 2019 – 15 – Unity

#### MOVED THAT

as Jesus prayed for the Church to be one, so the Synod of the Diocese of Fredericton commits itself to walk together, in the bonds of love and affection, recognizing diverse opinions on the matter of marriage in the church. We will care for one another and continue to strengthen our commitment to the proclamation of the Gospel and living and loving as Christ.

#### Motion 2019 – 16 – Diocesan Officer Reports and Diocesan Council Report Sandra Craft/David Peer

MOVED THAT this Synod receive the Diocesan Officer Reports and Diocesan Council Report as found in this convening circular and the annex to this circular.

#### Motion 2019 – 17 – 2018 Review Engagement Report and Financial Statements

MOVED THAT this Synod receive the Diocesan Review Engagement Report and Financial Statements for the year ending 31 December 2018.

#### Report of the Treasurer of the Synod

#### Mandated Responsibilities:

The Treasurer is appointed by Diocesan Council and under Section 10(2) of the Constitution is required to:

- a) receive all money belonging to or collected under the authority of the Synod, and disburse the same as the Synod shall direct,
- b) keep careful accounts of all money belonging to or collected and disbursed under the authority of the Synod and present those accounts to the Synod at each regular meeting of the Synod and to the Diocesan Council as it may require,
- c) transfer all property, books, records, documents and papers relating to its concerns that may be in the possession or control of the Treasurer to the successor or other person as the Synod may direct.

The Diocesan Treasurer provides financial information on a regular basis to the Finance Committee and to Diocesan Council. The financial statements for the year ended December 31, 2017 are on the website and December 31, 2018 are included in the Appendices of the Synod Convening Circular.

#### Diocesan Finances:

2017 - The financial results of 2017 were positive providing a surplus for the Diocese accounts due to the increased contributions to both Diocesan Trusts and Parochial Investments and the Operating Fund. The Operating Fund realized a surplus in the amount of \$0.21M mainly due to a reduced program spend and a modest unrealized gain on investments.

2018 - The overall financial results for 2018 were negative providing a loss due to the unrealized investment loss caused by market volatility. Excess revenue over expenditures before this loss, (revenue and expenses that we have more control over) was positive, \$0.95M. This was mainly due to higher realized investment income and overall lower expenditures that was reduced by lower contributions to funds. Additional details are in the statements prepared by Bringloe Feeney prepared on our behalf.

#### **Diocesan Shared Ministry Budget:**

The 2019 Diocesan Shared Ministry Budget focuses on the mission and ministry of the Diocese, in keeping with the diocesan mission statement. Support is provided to six major areas of ministry: Ministries with Youth 10.6%, Spiritual Development 0.5%, Stewardship 0.4%, Parish Development and Support 18.1%, Mission and Ministry 15.6% and Ministry Development and Education 9.4%. Incorporated throughout the various areas of ministry are grants, and contributions to support the Diocesan mission focus totaling \$720,629 or 29% of the total 2019 budget.

57.6% of the funding is from parish shared ministry support, 38.1% is allocations of designated or special funds, and investment income and the remaining balance from various miscellaneous sources. 84.2% of the budget is focused on providing either direct support to the parishes, or mission and ministry on behalf of the whole diocese. Synod office administration and diocesan governance account for the balance at 15.8% of the total expenditures, a reduction of \$15,000 year over year. Again, this year the overall shared ministry assessment budget remained unchanged. Our efforts have been to find efficiencies, streamline processes and focus on value added items to maintain the budget without reducing mission and parish support. In order to not place additional burden on the parishes it was also necessary to project a deficit of \$98,285 and reduce the year over year

spend for 2019. We continue to review and manage the financials. The ongoing challenge is to continue identifying and implementing cost savings throughout the year.

The continued parish support of the Diocesan shared ministry budget is encouraging at 98%. The current approach for parish support of the diocesan ministry budget, instituted in 2014, appears to be working in accordance with the objectives: an approach that is fair, equitable, and transparent; communicated and applied but flexible enough to recognize and accommodate extenuating circumstances. While some parishes are still challenged to contribute, some have been moved to contribute more in support of their fellow parishes while others have been contributing towards amounts that were previously written off. These parishes should be acknowledged for their support to the current budget.

#### Diocesan Trusts:

In 2017, the diocese received a significant transfer as a result of dissolution of "The Wiggins Home". Almost \$700 thousand dollars in total, to provide support of or for the benefit of young people in New Brunswick. We also received the additional funds totaling \$700 thousand dollars from the bequest by the late Miss Dorothy Roberta Wilkes. The generosity and care of these individuals in providing ongoing support for the Anglican Church in New Brunswick is indeed an example of stewardship in action and has allowed the diocese to focus on increasing ministry education and development opportunities throughout the diocese.

In 2018 there were no material contributions or changes with the trusts.

#### **Diocesan Support to the Parishes:**

The diocese remains committed to providing opportunities for parish leaders and congregations to gain insight, skills and knowledge that will help enhance parish operations and meet the constantly evolving challenges. The newly named Parish Officers Day, now offered to an expanded parish group, encourages leadership development and sharing of information on several topics. 2017 a Pre-Retirement Conference was held to provide information and assist clergy eligible to retire. We continue to search ways to reach out and assist parishes and leaders.

#### **Diocesan Youth Camps:**

The youth camps continue to be a major initiative of the diocese in terms of providing leadership and financial resources. Recognizing the role that these facilities play in shaping the future of young people, the diocese is devoted to providing leadership, capital and operational support. With that being said, the youth camps continue to be a major focus of financial discussion, in terms of existing operational obligations, funding and long-term viability.

Ongoing fundraising efforts continue for the Jonathan Young Memorial Amphitheatre. Construction commenced in early spring and is essentially complete. The structure is beautiful and an asset to the camp. It was used daily to hold music, drama, skits and other events.

#### **Diocesan Financial Administration:**

Financial and administrative systems and processes continue to be reviewed, not only for the current operations but also the ability of the financial, physical and human resources to face the challenges of the future needs of the Diocese and support for the Parishes. This is critical as in recent years the Diocese has assumed and provided more financial and administration support. Documentation of key processes is ongoing with continued efforts to streamline and make improvements as identified. Review and restructuring of the Diocesan Treasurer role was completed to ensure that the administrative role and responsibilities were sustainable in the long term and that diocesan priorities continue to be addressed. With the position of Diocesan Personnel and Safe Church Officer, Ben Bourque has alleviated some responsibilities in this area.

#### Challenges and Blessings:

I assumed the role of Diocesan Treasurer in May 2018. I was challenged by the need to get up to speed quickly and determine priorities in order to focus and manage my time over the many tasks and projects and others that still need attention. To add to this challenge, our team transitioned with Josh McDorman as the interim Finance and Administrative Assistant while Nicole Chouinard was out on maternity leave. Nicole has since returned and transitioned back as the Finance and Administrative Assistant. Josh has remained on for an interim period to assist with project work.

Although I am still relatively new to this team, I am blessed by the leadership and support of Bishop David Edwards, and respect for his caring guidance and support throughout the Diocese. As Diocesan Treasurer, I have the pleasure of working closely with him, the team at the Diocese and with so many people who are devoted and dedicated to making a difference. Your work is valued and appreciated. Lastly, although complex and challenging work, I am thankful and appreciative for this opportunity.

This past year has been very disappointing as far as returns on investment are concerned. The financial markets have been in a constant turmoil. We are however, concerned about the potential need for changes to our investment policies, which is expected to be a significant item in the coming year. The need for satisfactory returns to the Synod and Parish investments is very clear to all.

This being my last report as Chair of the Finance Committee, I want to express my sincere thanks to the many committee members who worked on this committee, the Property Committee, as well as the staff at the Synod office. The continuing strong support and direction provided by our Bishop and other clergy members has been most appreciated.

#### **Report of the Nominating Committee**

#### Mandate

The Nominating Committee is a standing committee of Diocesan Council with the purpose of facilitating the nominating process for specific vacancies in Diocesan representative roles, and ensuring elections and appointments are carried out as needed. The committee assists the Bishop and Diocesan Council in recruiting both clergy and lay persons for as many as 40 ministries within the Diocese. Within these areas of ministry, there are more than 250 roles for volunteers and Bishop's appointees within the diocese. Some are individual while many others serve as members on teams and committees.

#### **Current Membership**

Members include the Rt. Rev. David Edwards, the Ven. Cathy Laskey, the Rev'd Ann Fairweather, Mr. Trevor Holder, Mr. Robert Taylor and the Rev. Canon Walter Williams. Members welcomed Robert Taylor, elected member of Diocesan Council, in January 2018. The Committee expresses its thanks to Mr. Frank Morehouse (Vice-chair), who faithfully served on the committee since January 2016 until his resignation in May 2018. In June 2019, Robert was appointed Chairperson upon the resignation of Ann as Chair.

#### Election of Delegates to General Synod and Provincial Synod

The Nominating Committee organized the election of delegates and substitutes to General and Provincial Synod at the Nov 2016 Diocesan Synod. In response to feedback from prior Synods over the lack of knowledge about nominees to be elected, nominees were encouraged to prepare a 100 word, or less, statement to answer the question: Why do I want to be a delegate to Provincial Synod and/or General Synod? Of the 13 nominations from Greater Chapter Meetings, we were pleased that 12 nominees submitted responses for inclusion in delegates' registration packages. It was encouraging to have four youth nominations from the floor of Synod. Elections for General and Provincial Synod delegates and substitutes will be conducted during the Nov 2019 Diocesan Synod.

#### **Appointments Diocesan Council Committees and Teams**

With the appointment of the newly elected Diocesan Council in Nov 2017, the Nominating Committee assisted Diocesan Staff with the appointment of Diocesan Council members to standing committees, other committees and teams, based upon known vacancies and the skills and expressed interests of Council members.

Communication was initiated with Chairs and members of committees with no chairs, to gather information on members' desire for continued participation on respective Committees, Teams and Group. Vacancies were identified, and the majority of which have been filled by Diocesan Council members and Anglicans across our Diocese.

#### **Communication with Committee, Team & Group Chairs**

In March 2018 a memo was sent to Diocesan Committee, Team and Group Chairpersons to offer the Nominating Committee's assistance in filling vacancies and to seek assistance as well. It was stressed that "having a full complement of capable and committed members on committees and teams is our collective goal as well as ensuring that members represent our Diocese in terms of diversity of geographic area, gender and cultural demographics." Chairpersons were asked to advise us when a new member is needed along with some idea of the skill set that is needed and any other requirements they might have. Suggestions of skilled and interested people to fill the variety of volunteer opportunities within our Diocesan committees, teams, groups and individual roles was also mentioned.

#### **Report of the Director of Camp Medley**

#### Review of 2019

It has been a year to learn. The camp program went well, and we had great staff. I have identified some operational areas where improvement opportunities exist and worked on the grounds and facilities this year. I have worked with the Synod finance team to manage and categorize Medley finances. We finished the year close to budget, but I plan next year to reduce the diocesan contribution to the Camp.

Infrastructure maintenance this year included replacement screens in the chapel and old dining hall, trimming trees around the property, painting the nurse's hut, repairing the deck by the dining hall, improving accessibility to camper washrooms with ramps, and cleaning under the cabins. The amphitheater is now complete. The youth camps enjoyed using the facility this summer. Some groundwork needs to be done around it this fall and a clear protection on the wood remains to be completed.

I was able to take part in an accreditation of another New Brunswick Christian camp. We also had our camp accreditation done this year. The accreditation went well. These were important opportunities for me to understand the requirements Camps need to meet in New Brunswick and different ways Medley could meet them. I hope to connect with leaders from Camp Brookwood, St Michael's, and Choir School to see if Medley can offer any support. In addition, I plan to visit churches and connect with other ministries we have here in New Brunswick to see if Medley can offer support or resources.

We really need to improve how we provide financial support to campers and conduct Registration. We also need online forms to help gather the information we need to consider the applications of groups who want to use the facility. I will be working on this over the winter.

I would like to express my thanks to the staff, the many volunteers, and the financial supporters of the camp who made the programs we delivered this year possible.

#### Plan for 2020

Work for Camp Medley will focus on five areas over the next year:

- 1. Financial control;
- 2. Campership;
- 3. Structure of the program and the supervision of campers;
- 4. Infrastructure; and
- 5. Medley beyond children.

#### **Financial Control**

Steps were taken this year to break out and categorize Medley financial transactions. I have worked with the financial staff in the Synod office so that contributions to camp income and expenses are known. This will help identify aspects of camp operations for attention.

Our plan next year is to reduce the diocesan contribution identified for Camp Medley operations. One part of this is to separate Camp on the Road and Camp Medley finances. The diocesan contribution to the camp will also be reduced by better financial control, more efficient delivery of programs, and better use of camp facilities.

#### Campership

Supporting children to attend Camp Medley is a missional activity; Camp Medley's focus is introducing children to Christ and living in Christian community in a camp setting. Many of our campers could use financial assistance to attend Camp and I plan to identify opportunities and ways for individuals in our Diocese to participate in this activity.

We will also be developing criteria for campership support so that the use of diocesan funds in supporting campers is understood and clear.

#### Structure and Supervision

The structure of the program at Camp and the staff needed to execute it must align with the demand and the available resources. We will base our planning on 500 campers for youth camps next summer and target 70 campers per week. We may need to adjust programs and the number of camps to match the actual need.

We also need to identify our future camp leaders and the supervision structure. A review of Christian camps in New Brunswick has identified an opportunity. Other camps have a single leadership program. Rethinking how Camp Medley delivers leadership training may offer a more flexible structure for developing programs and developing people to deliver the programs.

#### Infrastructure

The Camp Medley infrastructure is a diocesan resource. The infrastructure is a key contributor to summer programming for youth, but Camp Medley has potential to support other Diocesan activities throughout the year. More intensive use of the facility will spread the cost of camp over a larger pool of users.

The camp needs an infrastructure plan linked to the current and potential uses of the facility and the maintenance requirements of the existing structures and equipment. Short- and long-term plans are in development for the facility and for equipment to support programs for faith formation, community living, and various program activities that range from low key activities to set piece programming such as canoeing, archery, and swimming.

#### **Medley Beyond Children**

Moving forward the camp must become a 3-season facility. A plan will be developed to facilitate this transition. Camp Medley also needs to support all-age use of the facilities. The bond between Camp Medley and our youth is important and it will continue, but the facility has the potential to support wider demands of faith formation, Christian community development and programs for all ages and for families.

Camp Medley is also an important part of the local community. Medley will work to strengthen this relationship, as it is another way Medley can provide a missional impact on the Gagetown area.

### **Independent Practitioner's Review Engagement Report**

#### 1. Nature of operations

The Diocesan Synod of Fredericton represents the administrative and episcopal head of the Anglican Church of Canada operations in New Brunswick. The organization is a registered charity and is exempt from income tax by virtue of paragraph 149(1) of the Income Tax Act.

#### 2. Significant accounting policies

These financial statements are prepared in accordance with Canadian accounting standards for not-for-profit organizations. The significant accounting policies are detailed as follows:

(a) Fund accounting

The organization follows the fund basis of accounting which provides for separate groups of accounts to ensure accountability for restricted assets. The funds established by the organization are as follows:

**Operating fund** reports general activities related to the unrestricted and internally restricted funds. Internally restricted funds include special purpose funds and designated funds reserved for future expenses. Internally designated funds earn interest income based on the closing balance at a rate of 3.5% (2017 - 5%).

Capital assets fund reports the assets, liabilities, revenue and expenses related to capital assets.

**Externally restricted funds** reports activities related to amounts where the donation and related investment income is restricted on usage. There are four separate funds including:

- *Diocesan trusts* have been established through estate bequests and are generally limited to the use of earnings only. Interest earnings are based on the annual rate of return of the overall performance of the investment portfolio [2018 (3.4%); 2017 6.73%]. No earnings are generated in years with a negative rate of return. Earnings in excess of the restricted capital are distributed as per the terms of each individual trust agreement.
- *Diocesan funds* have been established through estate bequests and other means and may not be limited to the use of earnings only. Interest earnings is calculated on the closing balance at a rate of 3.5% (2017 5%). Funds are distributed as per the terms of each individual fund.
- **Designated funds** have been established through donations, bequests, parish assessments, and interest from Diocesan trusts and Diocesan funds. Interest earnings is calculated on the closing balance at a rate of 3.5% (2017 5%). Funds are distributed as per the terms of each individual fund.
- *Special purpose* funds have been established through donations for a specified purpose. Interest income is not earned on these funds. Funds are distributed as per the terms of each individual fund.

#### 2. Significant accounting policies, continued

#### (b) Revenue recognition

The organization follows the restricted fund method of accounting for contributions to its restricted funds. Contributions to the restricted funds are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

Unrestricted contributions and revenue from shared ministry and parish assessments are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

Contributions restricted for the purpose of capital assets are deferred and amortized into revenue at a rate corresponding to the amortization rate for the related capital assets.

Investment income includes dividends, interest income, foreign exchange, and realized investment gains and losses. Investment income is recognized as revenue when earned, net of management fees and transaction costs. Unrealized investment gains and losses reflect the change in the fair market value of the investments at year end and are recognized in the Operating Fund.

(c) Investments

Investments are reported at fair value using quoted market prices.

(d) Capital assets

Capital assets are recorded at cost. The organization provides for amortization using the straight-line method at rates designed to amortize the cost of the capital assets over their estimated useful lives. One half of the year's amortization is recorded in the year of acquisition. No amortization is recorded in the year of disposal. The annual amortization rates are as follows:

Buildings	40 years straight-line
Furniture and fixtures	5 years straight-line

#### (e) Collections - antiques

The Diocese maintains a collection of antique furniture with an insured value of \$58,885. The collection is not capitalized. There were no maintenance expenses with respect to the collection in the current year.

(f) Contributed services

Volunteers contribute time to assist the organization in carrying out its mandate. While these services benefit the organization considerably, a reasonable estimate of their amount and fair value cannot be made and, accordingly, these contributed services are not recognized in the financial statements.

#### 2. Significant accounting policies, continued

#### (g) Post retirement benefits

The Diocese and its employees participate in a multi-employer contributory defined benefit pension plan (the General Synod Pension Plan of the Anglican Church of Canada). The Diocese also participates in the national Employers Group Benefits Plan (Retirees) which is a defined benefits plan for retired clergy. Both plans are owned and managed by The General Synod of the Anglican Church of Canada. The Diocese is only responsible for annual contributions.

The current year pension plan expense for the Diocese office and administrative staff was \$112,021 (2017 - \$87,233). The current year pension plan remittance for all Diocese staff and parish personnel including clergy was \$589,683 (2017 - \$570,073). The current year expense for the retired clergy benefits plan under the administration of the national office was \$94,466 (2017 - \$93,449).

#### (h) Financial instruments

The organization initially measures its financial assets and liabilities at fair value, except for certain non-arm's length transactions. The company subsequently measures its financial assets and financial liabilities at amortized cost, except for securities quoted in an active market, which are subsequently measured at fair value.

Financial assets measured at amortized cost include cash, parish receivables, and other receivables, advances to Camp Medley, and parish loans. Financial assets measured at fair market value include investments. Financial liabilities measured at amortized cost include payables, and loan payable.

(i) Use of estimates

The preparation of financial statements in conformity with Canadian accounting standards for not-forprofit organizations requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the balance sheet date and the reported amounts of revenues and expenses during the year. Actual results could differ from those estimates.

#### 7. Camp Medley - Related party

Camp Medley is a Christian youth program offered in New Brunswick that provides residential camping and Christian youth leadership development. The organization is a registered charity and is exempt from income tax by virtue of paragraph 149(1) of the Income Tax Act.

The Diocese owns the land and buildings on the property known as Camp Medley and appoints the director who oversees the day to day operations. The Diocese, in this capacity, controls this organization. At December 31, 2018 Camp Medley owes the Diocese \$77,343 (2017 - \$33,635). This liability is non-interest bearing with no fixed terms of repayment.

The financial statements of Camp Medley have not been consolidated in the Diocese's financial statements. An unaudited financial summary of Camp Medley as at December 31, 2018 is as follows:

#### 8. Guaranteed deposits

The organization has investment agreements with individual parishes and individual clergy members that guarantee the principal amount invested plus any interest income reinvested. The asset and liability associated with these agreements are recorded as guaranteed deposits in the operating fund.

For the parishes, interest income is paid semi-annually with an additional annual interest bonus, both payable at the discretion of the organization. In 2018, interest was paid at a rate of 3.5% (2017 - 3.5%, plus bonus interest of 1.5%).

For the clergy members, interest was paid monthly based on the closing balance at a rate of 4.5% (2017 - 4.5%).

\$ 20,049 to the Parish of New Bandon from the Parish of Sussex

The Diocese has guaranteed the debt of the Parish of the Nerepis and St. John to the Bank of Nova Scotia to a maximum of \$81,827.

#### 15. Lease commitments

Certain land and buildings that were part of the original school property have been leased to the Rothesay Netherwood School at a nominal rental of \$1 per year to December 31, 2100.

In 2016, the Diocese entered into an agreement with Partners for Youth Inc. to operate a facility for homeless youth. The property is leased to Partners for Youth Inc. at a nominal rental of \$1 per year.

#### 16. Financial instruments

(a) Credit risk

Credit risk is the risk that one party to a transaction will fail to discharge an obligation and cause the other party to incur a financial loss. The organization's main credit risks relate to its accounts receivable, loans receivable, and loan guarantees. The organization reduces its risk by performing credit valuations on a regular basis and granting credit on review of the applicant's ability to repay. In the opinion of management, the credit risk exposure to the organization is low and not material.

(b) Market risk

Market risk is the risk that the value of a financial instrument will fluctuate as a result of changes in market prices, whether the factors are specific to the instrument or all instruments traded in the market.

(c) Currency risk

Currency risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in foreign exchange rates. The organization is exposed to currency risk with respect to its investments. At December 31, 2018, foreign investments represent approximately 30% (2017 - 34%) of the total investment portfolio.

It is management's opinion that the Diocese is not subject to significant amounts of risks with respect to its financial instruments. The Diocese manages these risks by its Investment Policy Statement. This statement is reviewed annually by the finance committee and establishes policies for the management of its investments, dictates the Diocese's approach to growth, credit quality and profitability objectives. The overall objectives of the policy are to preserve and enhance the value of capital through adequate diversification in high quality investments and achieve the highest investment return within the level of acceptable risk. Subject to limitations, the organization only invests in equities and fixed income.
